市场展望：即使在美国股市暴跌后，能源市场奋力从新将价格提高上来的情况下，本周乙醇市场仍旧开高。最新数据显示，去年乙醇出口量为 13.7 亿加仑（或 409 万吨）比之前一年上升 17%，并比历史最高纪录 2011 年的出口量多 1.74 亿加仑（或 52 万吨）。CBOT 三月乙醇期货价比之前一周上涨 2.1%，中西部乙醇批发价格比上周上涨 3.1%至 39.67 美分/公升（150.16 美分/加仑）。

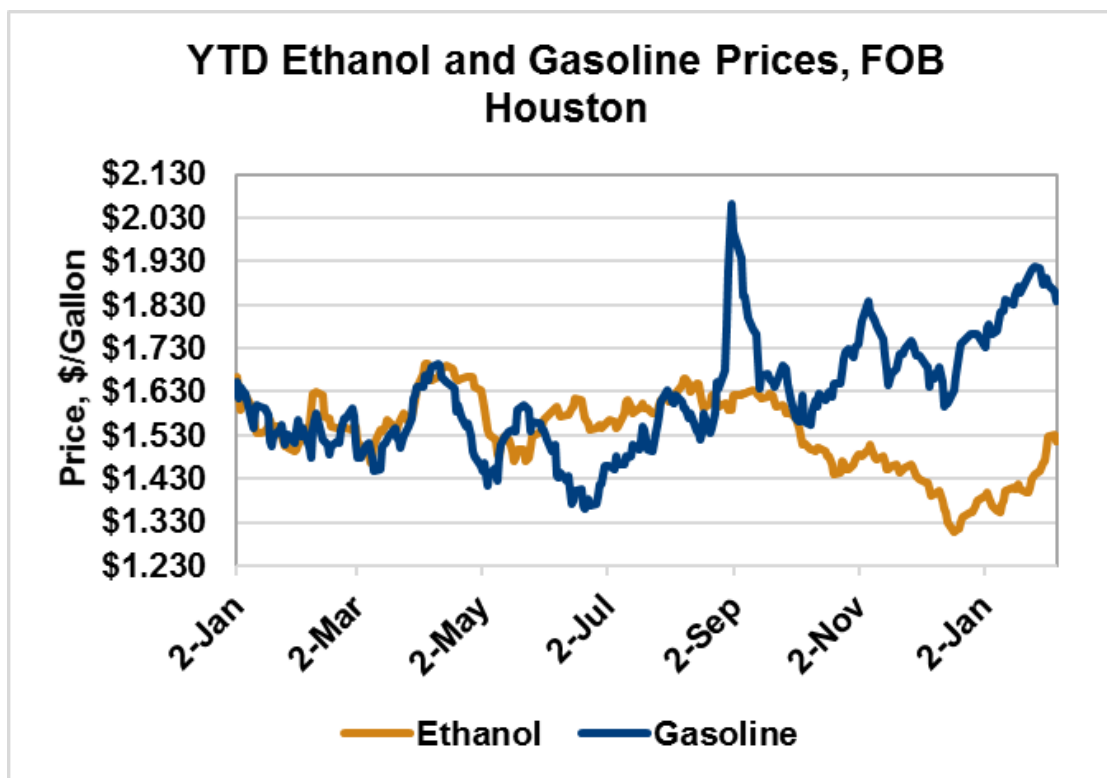
休斯顿乙醇现货离岸价比上周上涨 2.476 美分/公升（9.37 美分/加仑）或 6.5%。美国湾区汽油现货离岸价在前几周不断上涨，这使得乙醇更有竞争力。巴西 Santos 乙醇现货离岸价比上周上涨 0.6%或 0.34 美分/公升（1.29 美分/加仑）至 61.853 美分/公升（234.14 美分/加仑）

休斯顿-Santos 现货离岸价价差继续缩小至 21.387 美分/公升（80.959 美分/加仑），这使得价差达到区域性低点，但价差缩小速度有所放缓。

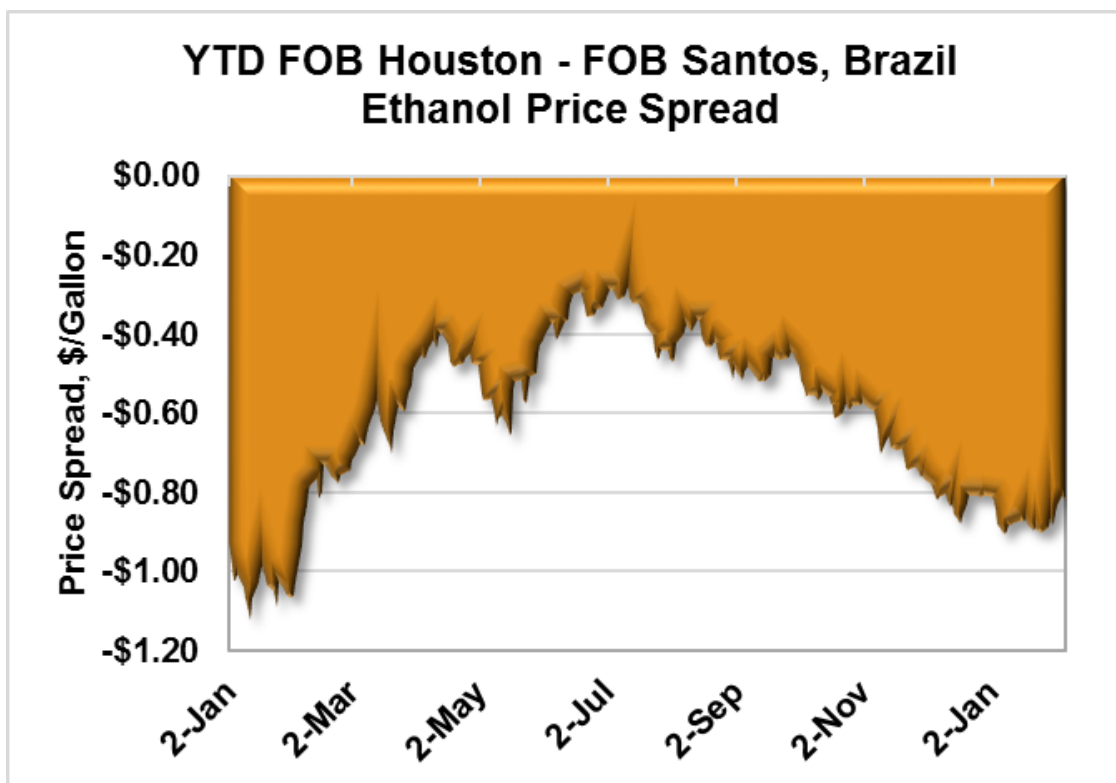
MTBE 价格比上周交易价格涨 4%至 60.77 美分/公升（230.04 美分/加仑）。MTBE 美湾地区现货离岸价比休斯顿地区乙醇现货离岸价高 20.303 美分/公升（76.85 美分/加仑）

BTX 组份价格略有坚挺，苯价格不变，甲苯价格上涨 4.1%，二甲苯价格上涨 1.3%。芳香烃加权平均价目前在 71.57 美分/公升（270.90 美分/加仑），比上一周上涨 1.9%。加权平均 BTX 价格比休斯顿地区乙醇现货离岸价高 31.10 美分/公升（117.74 美分/加仑）。

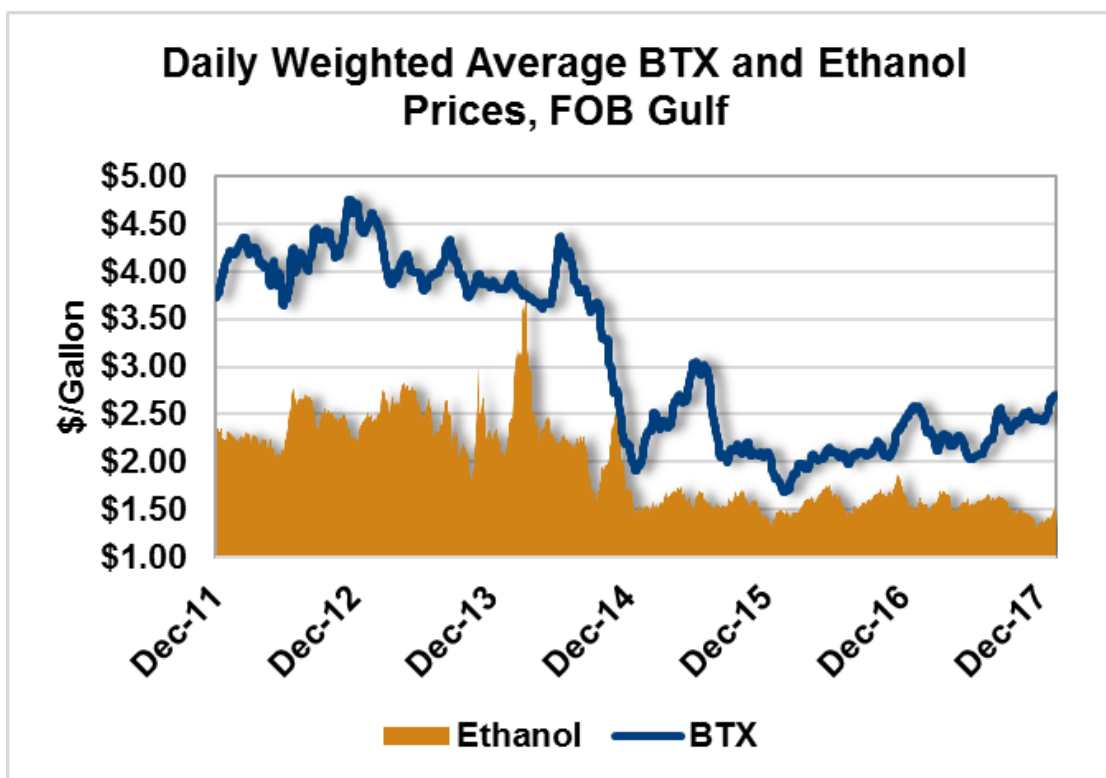
汽油和原油价格本周开低。RBOB 期货价格下降 3.3%或 1.59 美分/公升（5.97 美分/加仑），84 号辛烷值 ROBO 和 87 号辛烷值 CBOB 分别下降 3.2%和 1.1%。WTI 原油期货价格比上周下降 1.90 美元/桶，Brent 原油期货价格下降 1.59 美元/桶。



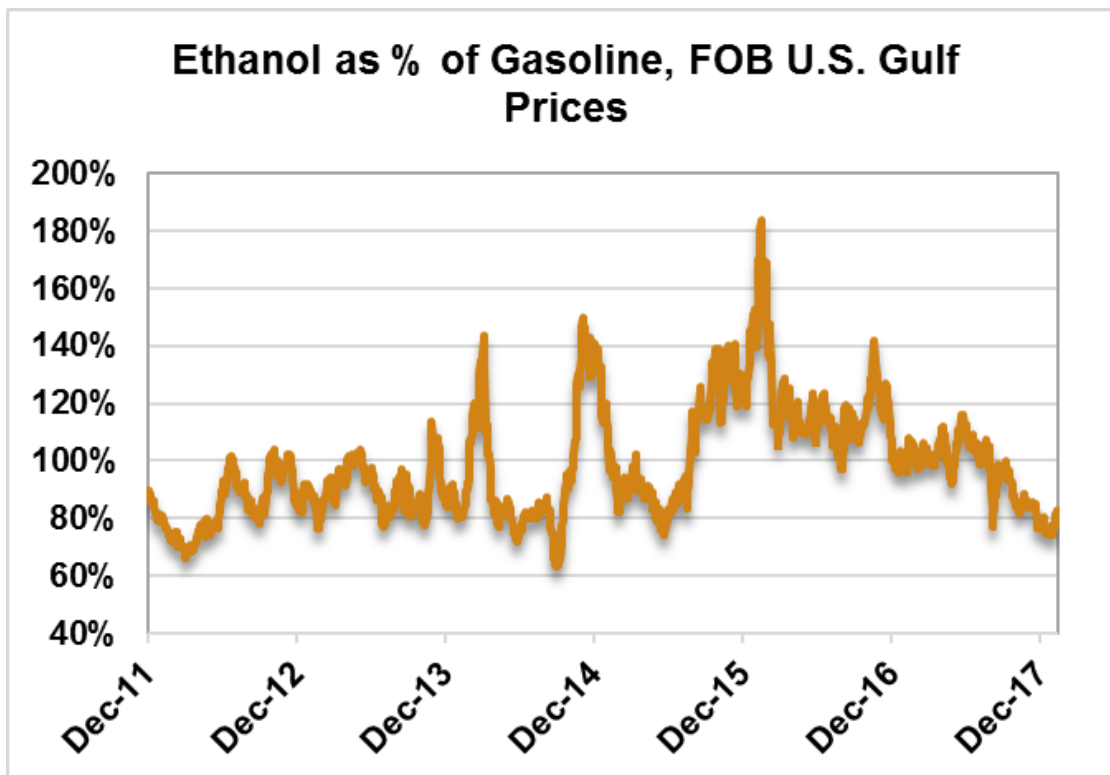

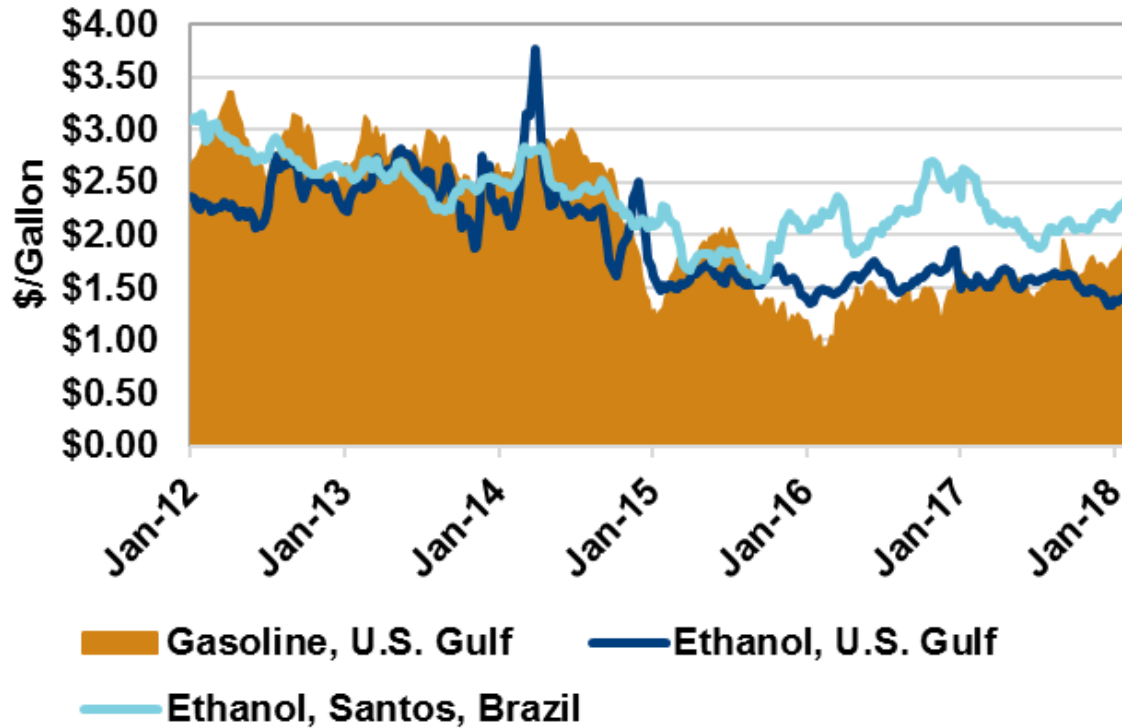

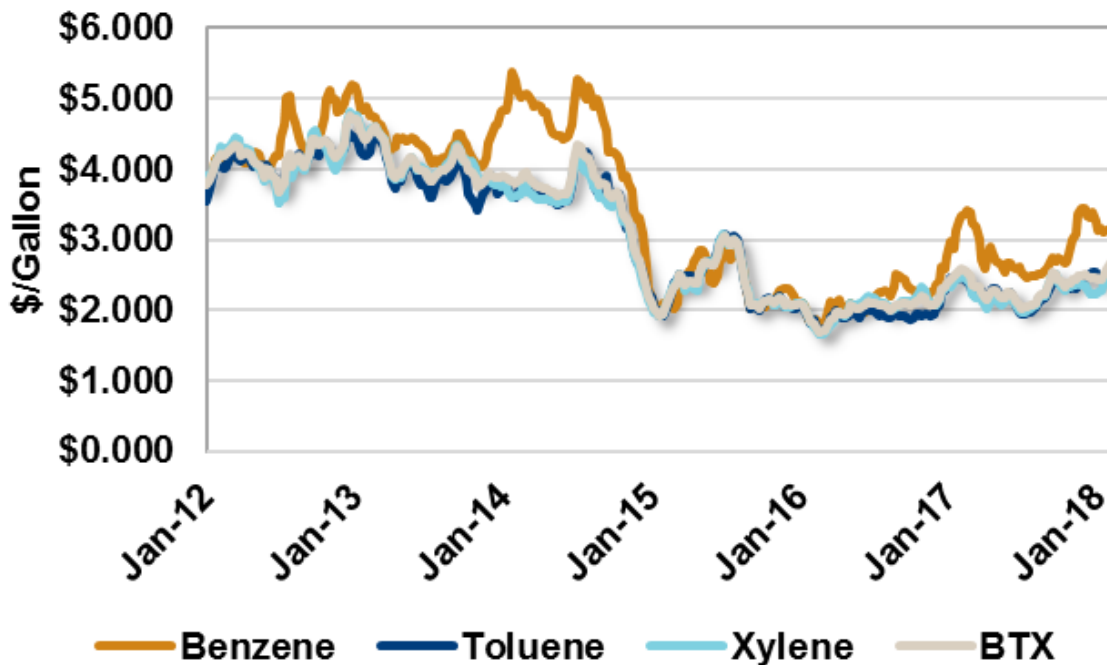

FOB Gasoline and Ethanol Prices

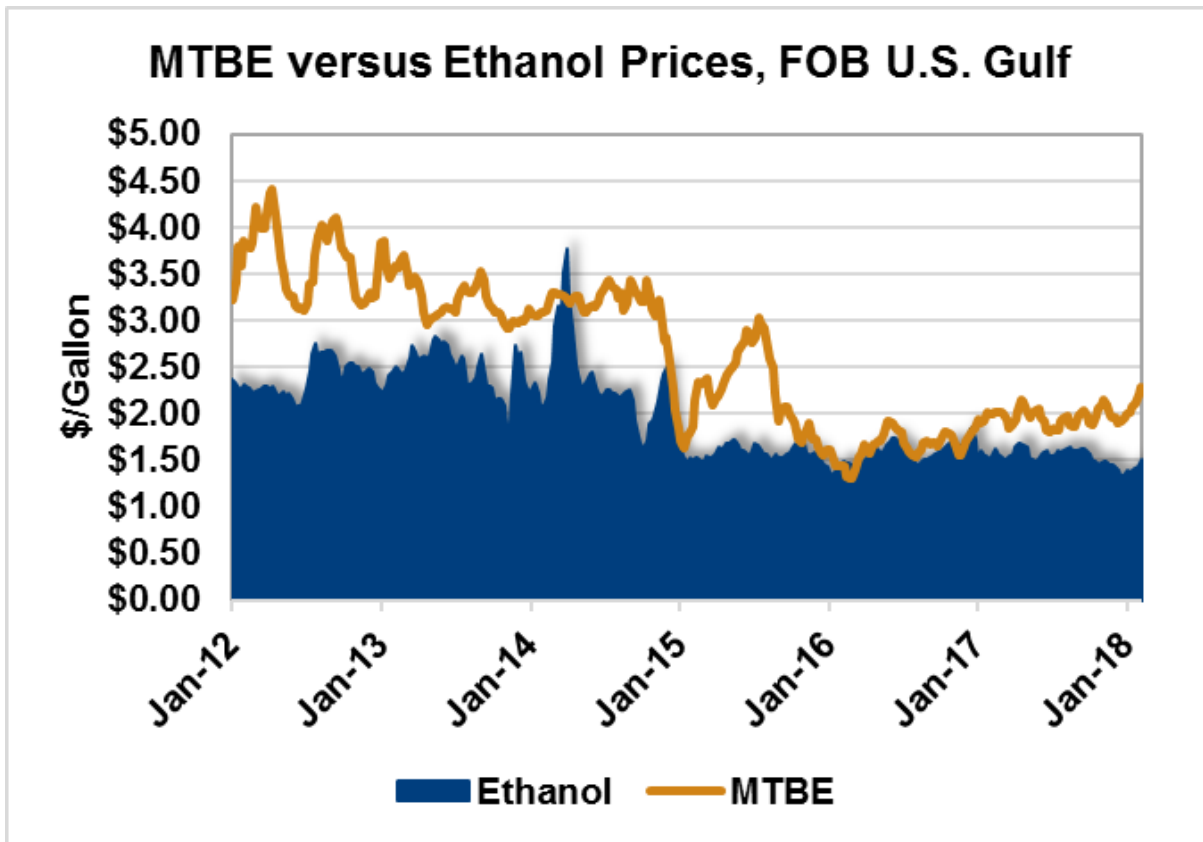

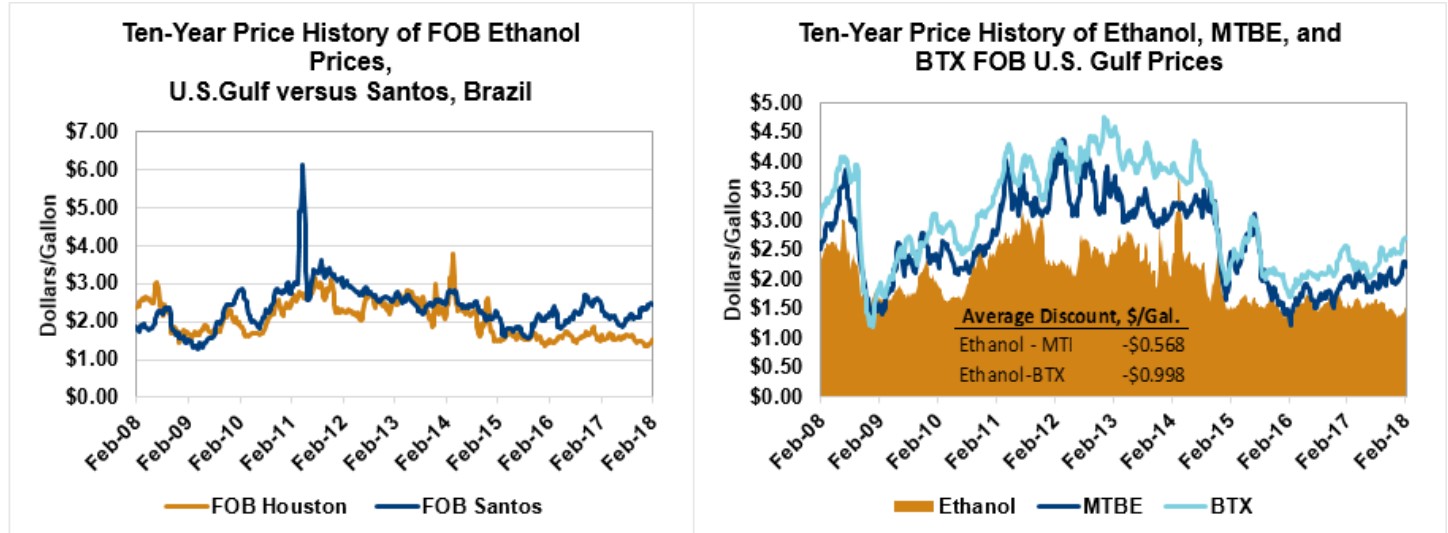
U.S. Benzene, Toluene, and Xylene Prices and Estimated BTX Value
