市场展望：随着美国能源市场整体上涨，本周乙醇市场略有上涨。CBOT 三月乙醇期货价比之前一周上涨 4.5%，中西部乙醇批发价格比上周上涨 3.1%至 40.82 美分/公升（154.52 美分/加仑）。

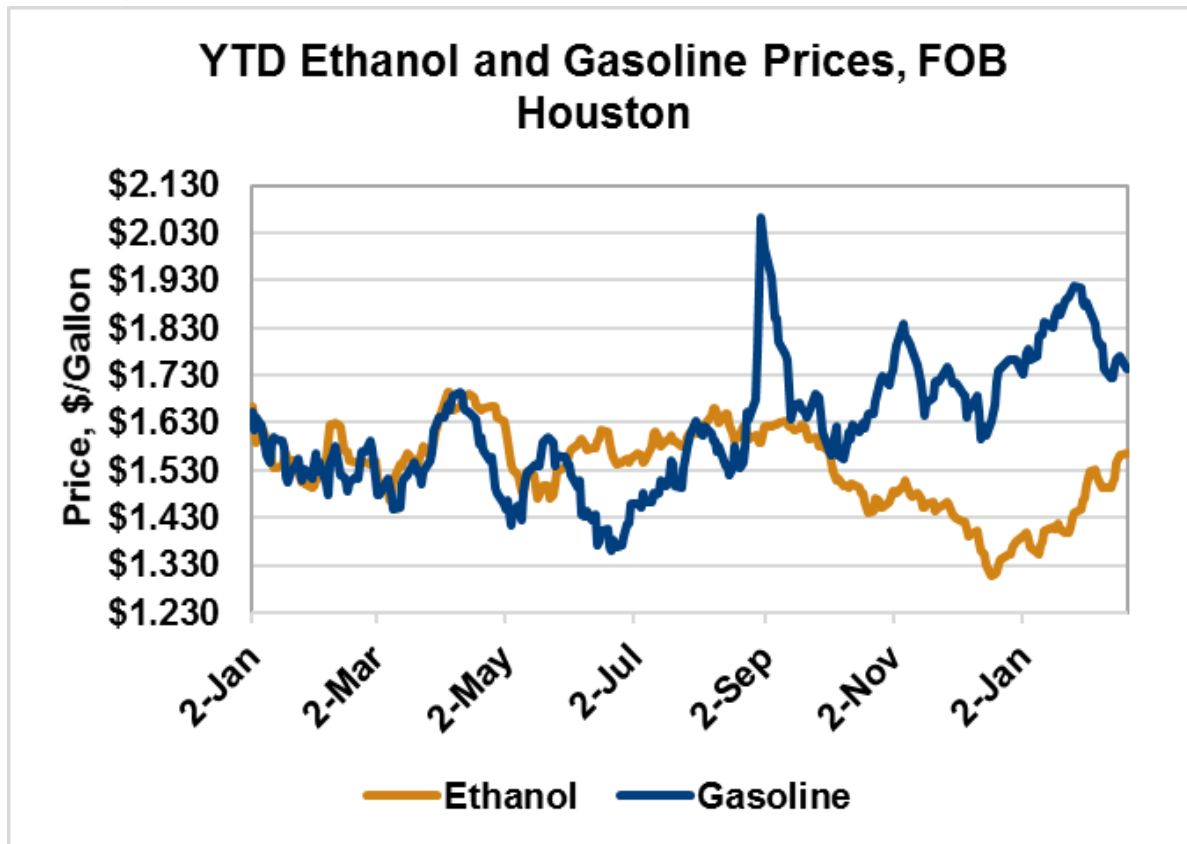
休斯顿乙醇现货离岸价比上周上涨 1.832 美分/公升（6.94 美分/加仑）或 4.6%。由于美国湾区汽油现货离岸价价格上涨，乙醇持续具有竞争力。巴西 Santos 乙醇现货离岸价比上周上涨 0.9%或 0.534 美分/公升（2.02 美分/加仑）至 61.936 美分/公升（234.46 美分/加仑）

休斯顿-Santos 现货离岸价价差缩小至 20.544 美分/公升（77.768 美分/加仑），这使得价差连续第二周走近六个月低点。

MTBE 价格比上周交易价格降 3.4%至 56.58 美分/公升（214.19 美分/加仑）。MTBE 美湾地区现货离岸价比休斯顿地区乙醇现货离岸价高 15.19 美分/公升（57.50 美分/加仑）

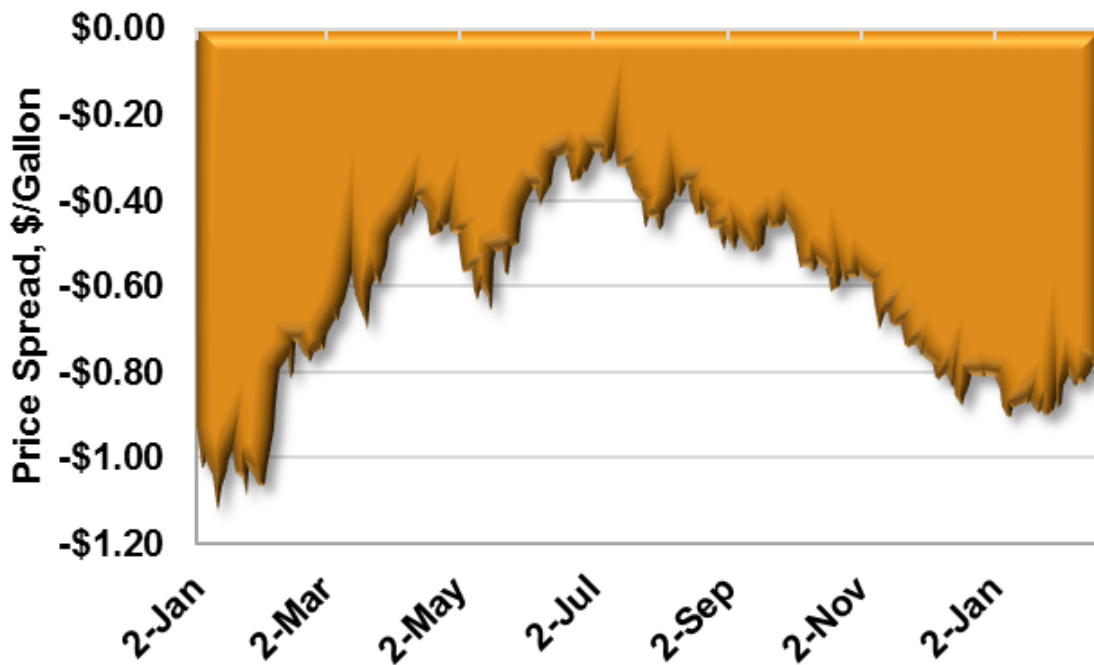
BTX 组份价格略有坚挺，苯价格上涨 1.4%，甲苯价格上涨 4.0%，二甲苯价格上涨 6.1%。芳香烃加权平均价目前在 75.13 美分/公升（269.38 美分/加仑），比上一周上涨 4.9%。加权平均 BTX 价格比休斯顿地区乙醇现货离岸价高 33.74 美分/公升（127.72 美分/加仑）。

汽油和原油价格本周开低。RBOB 期货价格下降 0.2%或 0.12 美分/公升（0.49 美分/加仑），84 号辛烷值 ROBO 和 87 号辛烷值 CBOB 分别下降 1.7%和 2.1%。WTI 原油期货价格比上周上升 35 美分/桶，Brent 原油期货价格上升 29 美分/桶。



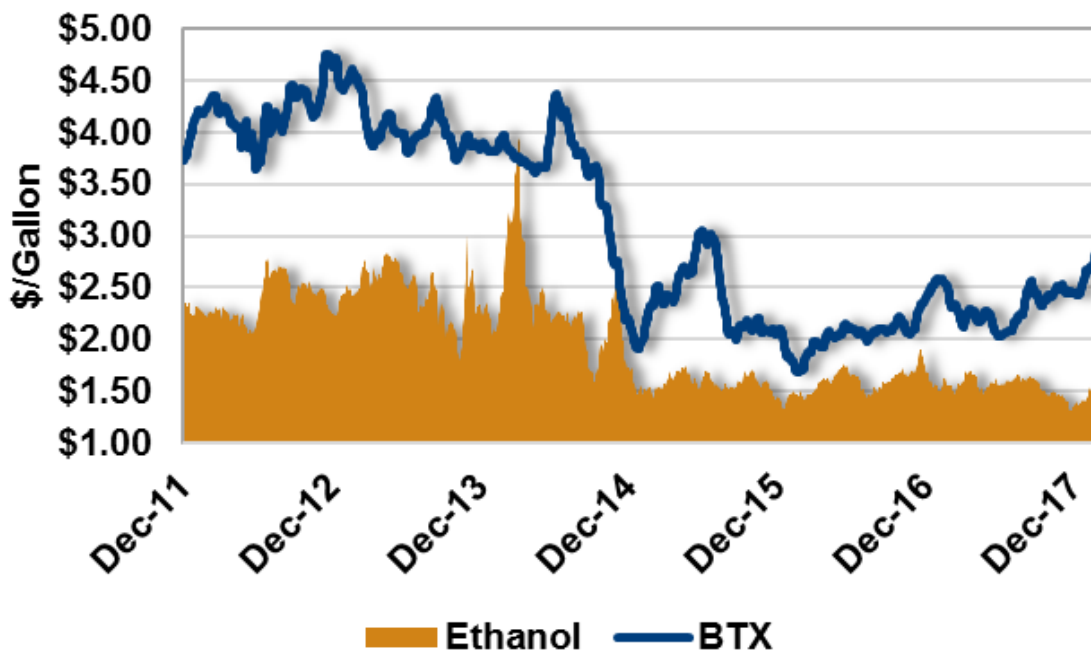

YTD FOB Houston - FOB Santos, Brazil Ethanol Price Spread



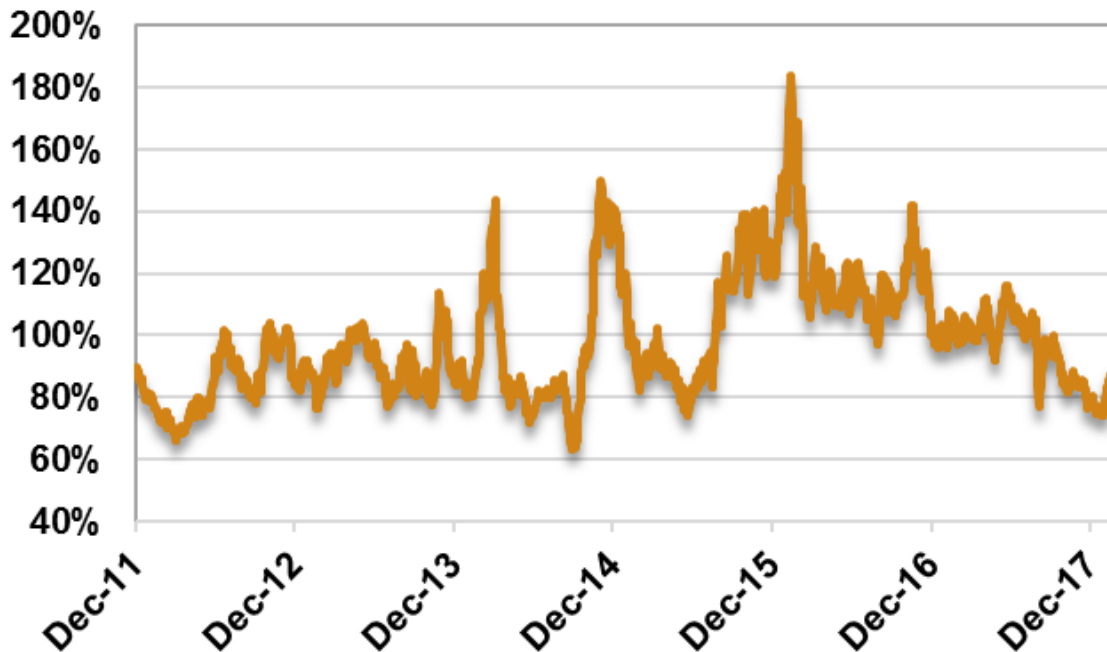

Daily Weighted Average BTX and Ethanol Prices, FOB Gulf



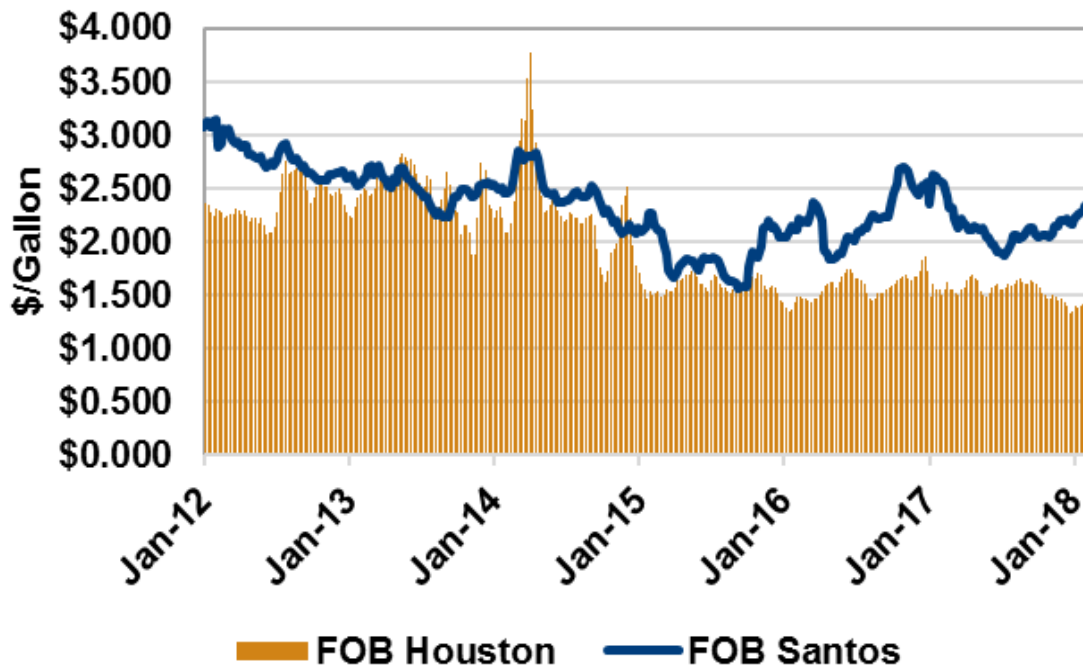

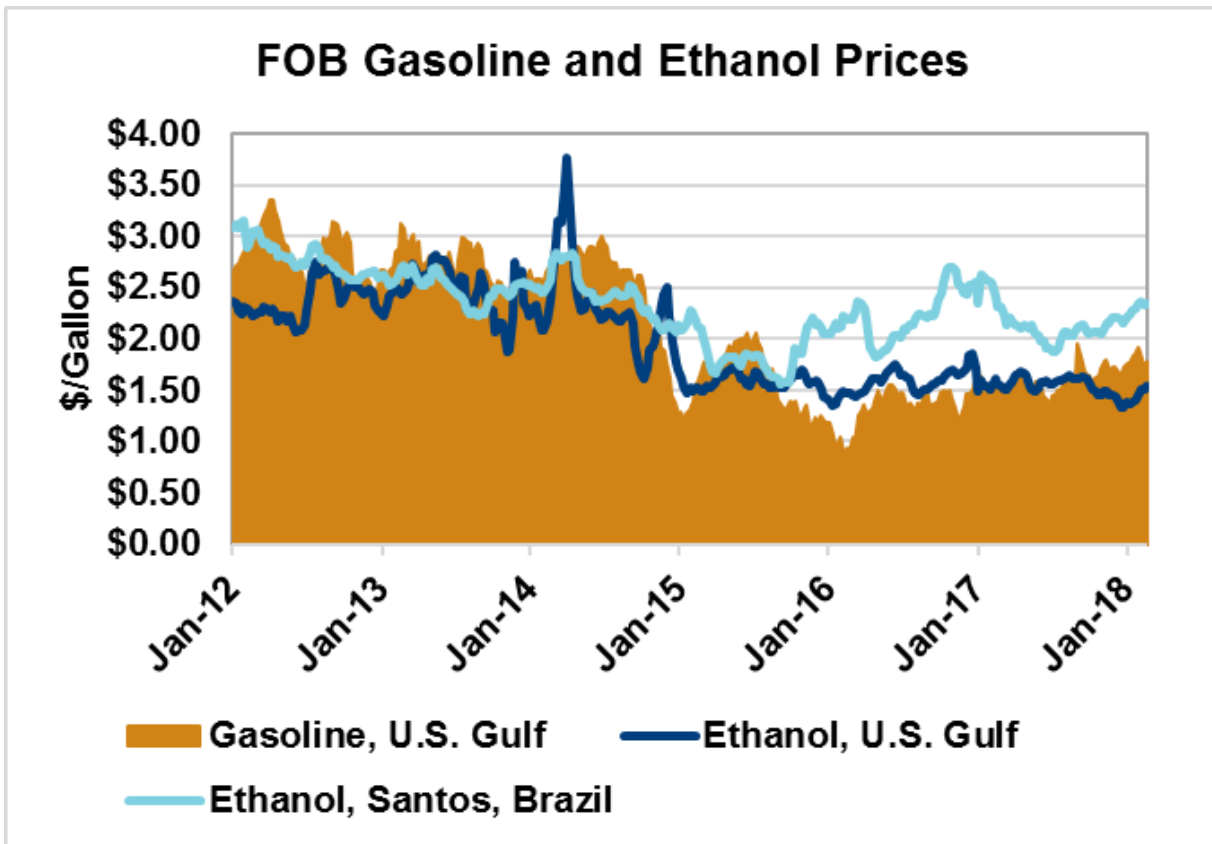
Ethanol as % of Gasoline, FOB U.S. Gulf Prices



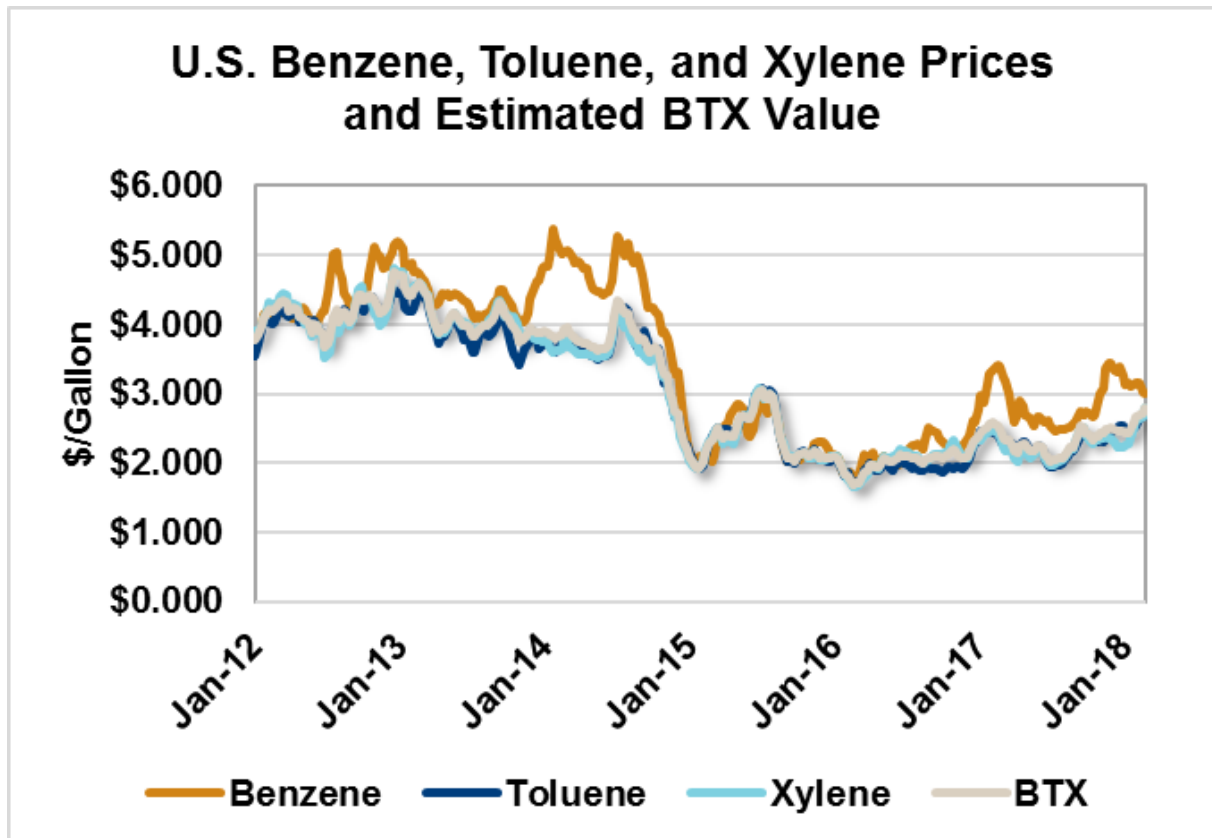

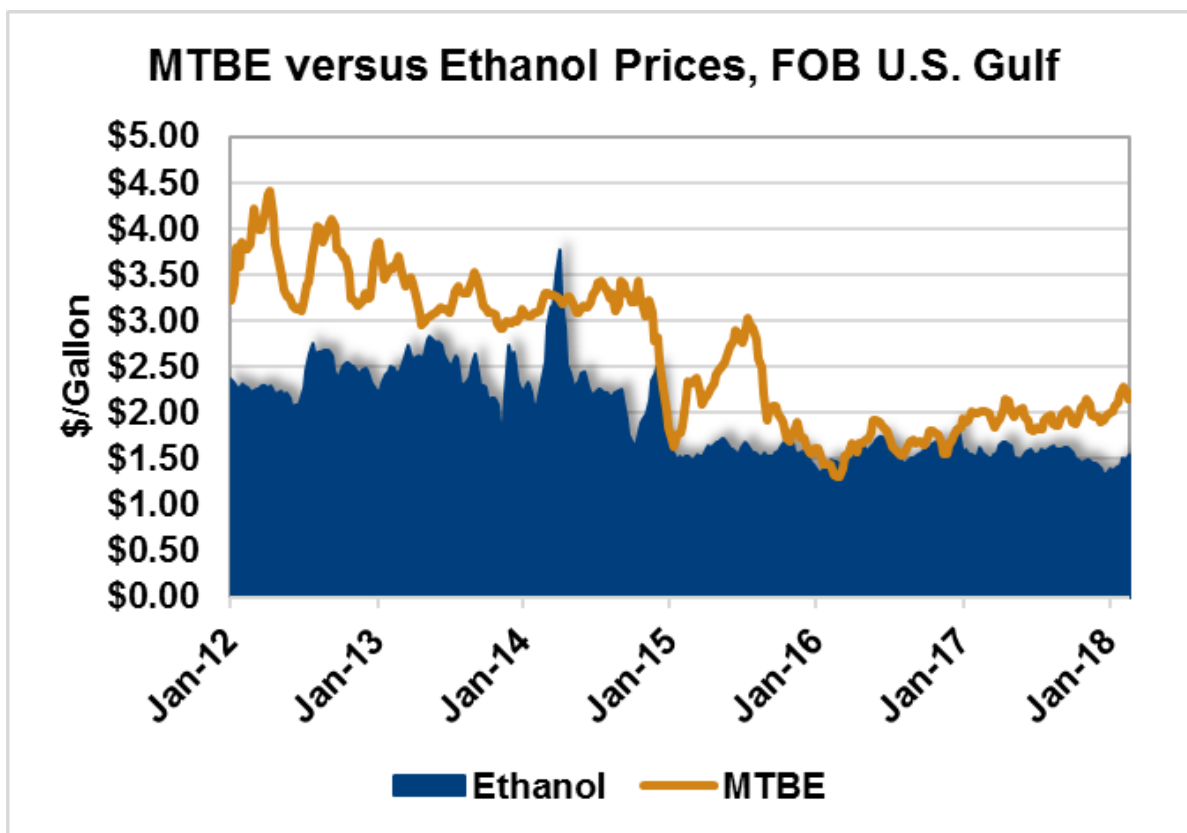
FOB Ethanol Prices, U.S. Gulf and Santos, Brazil



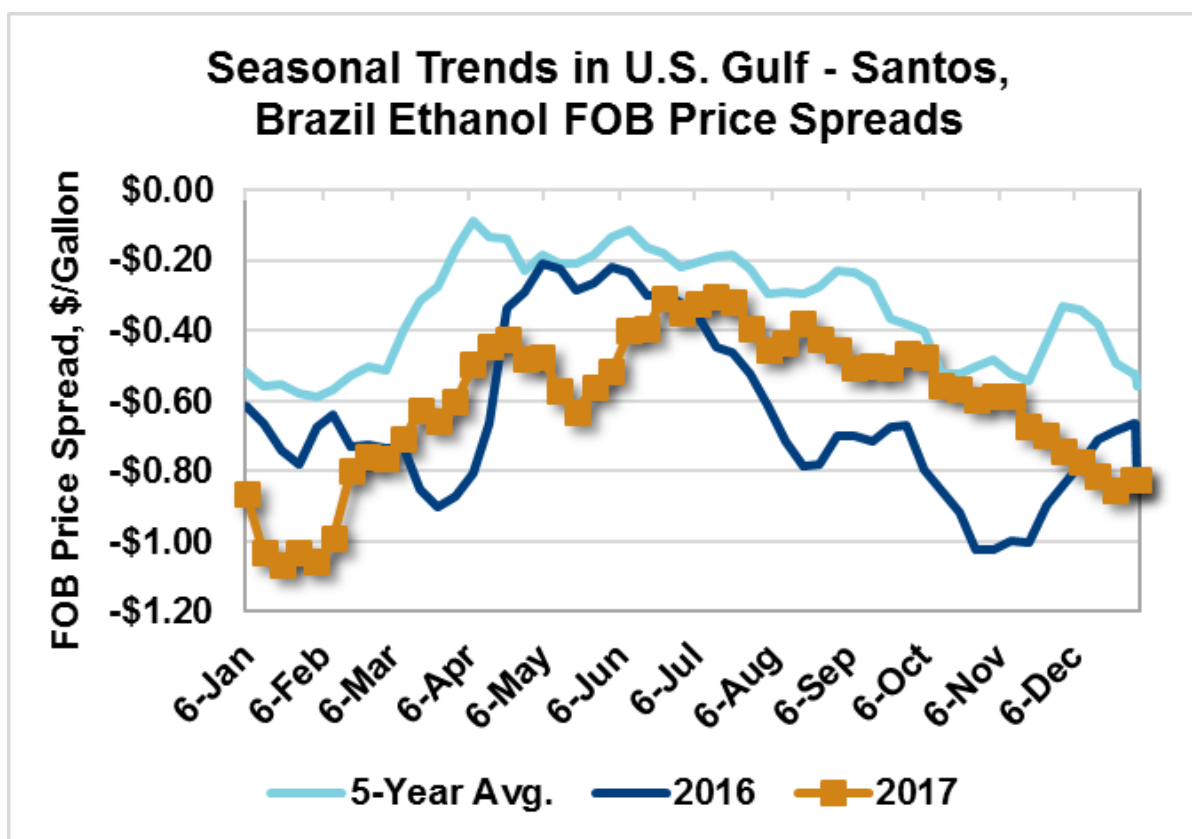
