市场展望:美国乙醇及能源市场本周开盘涨跌不一,乙醇价格走高而原油汽油价格走低。三月 CBOT 乙醇期货价格比上周上涨 5.1%,中西部乙醇批发价格比上周上涨 2.9%至 38.46 美分/公升(145.60 美分/加仑)。


休斯顿乙醇现货离岸价 FOB 比上周上涨 3%或 1.126 美分/公升(4.26 美分/加仑)。预计本周乙醇价格会由于近期美国乙醇产量下降而持续上涨。巴西 Santos 乙醇现货离岸价 FOB 比上周上涨 2.1%或 1.297 美分/公升(4.91 美分/加仑)至 61.741 美分/公升(233.715 美分/加仑)


休斯顿-Santos 现货离岸价价差再次向美国原产地货倾斜,但减少 0.171 美分/公升 (0.65 美分/加仑)至 23.489 美分/公升 (88.915 美分/加仑)。闭盘价格使价差距离近 6 个月最小价差只有几美分的距离。


